Accepting Applications for High School Youth Tour Trip



T.I.P. Rural Electric Cooperative is looking for high school sophomores, juniors and seniors (whose parents or guardians are members of T.I.P. REC) with a passion for government and public service to apply for a once-in-a-lifetime trip to

Washington, D.C. in June!

For over 65 years, Iowa's locally owned rural electric cooperatives have been sending deserving rural Iowa students to our nation's capital to participate in the national electric cooperative Youth Tour.

One student will be selected from eligible candidates to attend the 2024 Youth Tour in Washington, D.C., from June 15-21 along with 40 other student leaders from Iowa. The Iowa Youth Tour group will join with hundreds of students from across the country as they learn more about electric cooperatives and American history and come home with a greater understanding of their role as American citizens. Students will also learn about U.S. government and meet with their members of Congress. On the trip, students take in the sights of D.C. as they visit monuments, museums and historical landmarks. Students who go on Youth Tour often call it the trip of a lifetime!

When is Youth Tour? June 15-21, 2024 (orientation on the evening of June 15 in Des Moines, then fly out to D.C. on June 16)

Who can apply? Only children whose parents or guardians are members of T.I.P. REC are eligible to apply; the student must be a current sophomore, junior or senior. The application process consists of completing an application and answering a questionnaire.

What is the cost?

There is NO cost to the student who is selected to go on the trip. All expenses are paid by T.I.P. REC as part of our ongoing commitment to the youth in the communities we serve.

Attention Seniors - Scholarships Available

T.I.P. Rural Electric Cooperative takes pride in helping develop leaders in the communities we serve so we are offering a scholarship program to recognize academic and community achievements made by young adults. These scholarships are considered an investment in the economic future of rural areas.

T.I.P. REC is again offering three scholarship opportunities:

- One \$500 scholarship will be awarded to each school district in our service territory. These scholarship applicants must be graduating seniors whose parents/guardians are members of T.I.P. REC. Applicants must plan to enroll in an accredited two-year or four-year college, university or vocational/technical school.
- One \$1,000 will be awarded to a graduating senior that is planning to enroll in an accredited Lineworker Program. The applicants parents/guardians do not have to be a member of T.I.P. REC but the applicant must attend a high school within our service territory.
- In addition to the above scholarships, a \$500 scholarship will be awarded to any T.I.P. REC intern who is planning to enroll in an accredited two-year or four-year college, university or vocational/technical school or accredited Lineworker Program.

All applicants must fill out a scholarship application and complete the scholarship submittal requirements listed on the application.

- Scholarships will be distributed to the student payable to the college they are attending and to the student.
- The application deadline is April 12, 2024, and the scholarships will be awarded in May.

Suds and Savings

Your clothes washer and dryer account for a significant portion of energy consumption from major appliances, and let's face it - laundry is no one's favorite chore. Make the most of your laundry energy use! There are several easy ways you can save energy (and money) in the laundry room. The Department of Energy recommends the following tips for saving on suds:

- 1. Wash with cold water. Switching from warm water to cold water can cut one load's energy use by more than half, and by using a cold-water detergent, you can still achieve that brilliant clean you'd normally get from washing in warm water.
- 2. Wash full loads when possible. Your washing machine will use the same amount of energy no matter the size of the clothes load, so fill it up if you can.

- 3. Use the high -speed or extended spin cycle in the washer. This setting will remove more moisture before drying, reducing your drying time and the extra wear on clothing.
- **4. Dry heavier cottons separately.** Loads will dry faster and more evenly if you separate heavier cottons like linens and towels from your lightweight clothing.
- **5. Make use of the "cool down" cycle.** If your dryer has this cycle option, you can save energy because the clothes will finish drying with the remaining heat in the dryer.
- **6.** Use lower heat settings to dry clothing. Regardless of drying time, you'll still use less energy.
- 7. Clean the lint filter after each drying cycle.
- **8. Purchase ENERGY STAR®-rated washers and dryers** which use about 20% less energy than conventional models.

State Law Requires Notification of Alternate Energy Production



In 2012, the Iowa Legislature approved a bill that requires notification to electric utilities prior to installing an alternate energy generator.

The notification requirement applies to any type of electric generating technology including:

- solar
- wind turbine
- waste management
- resource recovery
- refuse-derived fuel
- agricultural crops and residue

Under this legislation, the owner of an alternate energy production facility must provide <u>written</u> notification to their electric utility at least 30 days before construction or installation of the generator.


