

2024 Welcome Back Legislative Reception

During the 2024 Welcome Back Legislative Reception in downtown Des Moines, employees and directors from Iowa electric cooperatives discussed concerns and priorities with state legislators. The Iowa Association of Electric Cooperatives hosted the annual reception on January 9 in conjunction with the Iowa Biotechnology Association, the Iowa Communications Alliance, the Iowa Institute for Cooperatives and FUELIowa.

The event provided a valuable opportunity to meet with state legislators at the beginning of the 2024 Legislative Session to discuss issues that impact rural electric cooperatives and the communities we serve.

For example, we're concerned about the potential establishment of Integrate Resource Plans (IRPs) in Iowa Code. IRPs would essentially force the early retirement of carbon-based electric generation facilities, resulting in stranded costs and reliability concerns for the memberowners we serve. Iowa's locally owned and governed electric cooperatives continue to support an "all-of-theabove" power generation strategy that ensures reliable and affordable electricity for our members.

In the coming months, the Iowa General Assembly will be addressing a multitude of issues, including energyrelated matters that are central to Iowa's rural economy. Nominating Committee Members Needed for 2024 Election

In 2024, directors will be elected from **District 1 and District 3.**

Board Districts and Director Changes in 2024

With the upcoming retirement of a board member who is up for re-election this year, the Board of Directors took the opportunity and voted on some changes for 2024.

First, with the upcoming retirement of a director, they voted to decrease the number of directors from nine to eight. The ninth director will fulfill their term through 2024 until after our Annual Meeting.

With eight directors, our member-owners will remain well represented in their districts. These eight directors will be able to govern and guide your cooperative successfully, well into the future.

In addition, they decided to adjust the districts so now there will be four districts instead of nine. Each will have two directors per district, up for re-election in opposite years. This will enable each district to have a more equal number of member-owners per director. Pictured below is the new Board District map.

2023 Patronage Dividend Allocation

Your patronage dividend is one of the primary benefits of being a member-owner of your non-profit rural electric cooperative. Our goal is to provide you with electricity at a price that is as close to cost as possible.

Upon approval by your Board of Directors, T.I.P. members who had electric service during the year 2023 will receive a patronage dividend assignment. Your portion of this assignment is based on the amount of electricity you purchased from the cooperative in 2023 (If you had multiple services with T.I.P., these are included in the allocation amount.)

The patronage dividend allocation notice will be printed on current members' electric bills that will be mailed in April. Those who were members in 2023 who no longer have electric service with T.I.P. will receive a notice in the mail. The allocation has no cash value and cannot be used towards payment of electric bills.

If a member is deceased, the member's heirs need to contact the cooperative's office to discuss payment options. If you were a member and have a change in address, please keep the cooperative informed. This will ensure any future patronage checks will be mailed to you correctly.

2023 Audit Completed



Each year your cooperative is required to have an audit of its books by a Certified Public Accountant to check that proper accounting practices are followed.

Spring has arrived again and T.I.P. is continuing our pole testing, treatment, and replacement program. We test and treat our 1,700 miles of overhead line over a ten year period, or approximately 170 miles per year. We have hired SBS Inspections Inc. from Olathe, CO, again this year. Our overall average of poles rejected the first time through was 3.89%, 0.78% the second time through, and 2.19% the third time through.

Around the end of March or early April, SBS Inspections Inc. will start testing and treating approximately 3,600 poles in the **outlined** areas above which include our **Chelsea** and **Madison** substation areas. These men dig a hole about 18 to 24 inches deep and about 12 inches out from the pole. After exposing the wood, the poles are inspected and treated with a wood preservative, and then the hole is backfilled and the dirt tamped into place. This groundline treatment of wood preservative should extend the pole's life at least another 10 to 20 years.

SBS Inspection crews will be using pickups and 4-wheelers which will be marked with "Sub-Contractor for T.I.P. Rural Electric Cooperative" signs.

Changing out the rotted poles that are beyond saving and giving a groundline treatment of wood preservative to other poles helps to provide you with more dependable electric service in the future.
