# 2019 Central Iowa Power Cooperative Power Supply Report By: Craig Stallman T.I.P. REC's Representative on the CIPCO Board of Directors



If 2018 was a groundbreaking year for Central Iowa Power Cooperative, then 2019 was a year of executing strategy. on The opportunities afforded by change produced strategies to sustain connections within our broad electric cooperative network as

well as connections to CIPCO's proud past and future vision. The organization rolled up its sleeves and got to work implementing new strategic priorities along with new generation projects designed to partially replace output from one of CIPCO's primary sources of energy, the Duane Arnold Energy Center (DAEC), set to close in October of 2020.

These new generation projects fall right in line with CIPCO's goal of providing a diverse, 24/7 energy portfolio. In particular, progress continued on Wapello Solar, a 100 MW facility on 850 acres in Louisa County, from which we will purchase 100 percent of its output. Developed by Clēnera, LLC, Wapello Solar is Iowa's largest solar project. In 2019, we completed a transmission system impact study for when Wapello Solar is placed into service and worked with the developer as they obtained zoning approvals along with a generating certificate from the Iowa Utilities Board. We expect Wapello Solar to come online in late 2020. In addition, an \$85 million repowering project is taking place at the existing Summit Lake Generating Station in Creston. The modernization project for the 70-yearold plant will add 55 MW of efficient natural gas-fired reciprocating engines to CIPCO's portfolio, while retiring the old steam engines. Significant work took place throughout the year, with Creston transmission crews rerouting substantial lines in preparation for the Summit Lake North substation deconstruction and rebuild. Demolition work is complete on the substation, the office building, the transmission garage and diesel plant. The new engines are expected to be in place and operational in late 2020.

T.I.P. REC and CIPCO strive to provide safe, affordable and reliable power to our consumer-members across the system. When it comes to safety, we're proud of CIPCO's achievement of two million hours worked over 10 years without a lost-time injury. In addition, the implementation of the Low Voltage New-To-Replace-Old (NTRO) program in 1986 and the expansion of it in 1995 includes over 845 miles of rebuilt line. NTRO, along with sound operating and maintenance programs, helps ensure our power supply system attains the high degree of reliability our consumer-members expect and deserve. CIPCO's system-wide 2019 outage rate was 0.44 hours per consumer. This is the eighth consecutive year in which outage totals were less than the target of one hour per consumer.

Financial strength is integral to our success and has led to strong credit ratings, stable rates that are now the lowest among G&Ts in the Midwest, and access to borrowing capital to complete system upgrades and enhancements cost effectively. Fitch Ratings recently completed its annual review and affirmed CIPCO's "A" Issuer Default Rating and its Rating Outlook as Stable. The unexpected early closure of DAEC underscores the important actions taken over many years to manage risk and position CIPCO to withstand the loss of a vital generation resource. As a result, CIPCO has managed through this period of change by adjusting its future resource strategy while maintaining stable or declining rates as new cost-effective resources are secured.

CIPCO's 2019 average system rate was the lowest in more than 10 years.

Returning patronage capital is a fundamental component of the cooperative business model. CIPCO remains dedicated to sound financial practices that allow margins to be returned to its members in the form of patronage. During 2019, CIPCO returned patronage totaling \$555,581 to T.I.P. REC.

In today's energy-conscious world, CIPCO and T.I.P. REC are committed to ensuring consumer-members use energy wisely and utilize available options to reduce excess energy consumption. As a result of these efforts, CIPCO and its member systems issued energy-efficiency rebates saving approximately 13,233,348 million kWh. In comparison, the average house uses nearly 11,000 kWh a year, according to the U.S. Energy Information Administration. That includes 814,392 kWh savings for T.I.P. REC members.

I'm proud of the actions taken in 2019 to sustain our connections within the rural electric industry. Our actions have strengthened CIPCO's mission to provide consumer-members with wholesale power and services in a safe, reliable, and cost-effective manner. Thank you for the opportunity to serve as your representative on both the local board of directors and the CIPCO board of directors. I am proud to say, as a result of decisions made in 2019, T.I.P. REC's consumer-members, as well as the entire CIPCO system, will be well-served now and into the future.

# Your Cooperative Continues its Aggressive Brush Control Program



Evidence for the need to control growth of vegetation along power line right-of-way is easy to see in rural areas. Overgrown rightof-way can cause problems during severe weather and can make it difficult

to reach trouble spots to make repairs. This brush control program enables your cooperative to provide you with more reliable electric service.

In a continuing effort to control brush growth, T.I.P. Rural Electric Cooperative has hired Midwest Spray Team & Sales, Inc. to treat vegetation in power line right-of-way with governmentally-approved herbicides. They will start the program the first part of July, using the foliage herbicides of Krenite S and Escort XP, which are foliage absorbed and are non-volatile. The herbicides will be applied with a hand-held nozzle. Midwest Spray Team & Sales, Inc. will follow up in the fall with a basal treatment, using Religate, Polaris SP and basil oil to treat the areas they could not foliage spray. Growth in county road ditches will be sprayed, but if the Midwest crew has any questions, they will attempt to contact the landowner before spraying.

This year, Midwest Spray Team crews will be treating power line right-of-way in the Marengo, Hayesville, Webster, and Madison substation areas.

## Bear Creek Dairy LP Drive-Thru Provides a Welcome Break During the Covid-19 Pandemic

On a beautiful, sunny day in May the Jan and Dorine Boelen family, (five kids and their wives, fiance, girlfriends and grandkids are very involved in their family business), owners and operators of Bear Creek Dairy LP, invited everyone to jump in their vehicles and take a drive in the country for an enjoyable break from the Covid-19 pandemic.

Approximately 500 people attended the drive-thru dairy farm event which gave everyone a chance to view their dairy farm operation, enjoy homemade chocolate chip cookies baked by their daughter, Dieuwertje, who is better known as Dee's Dutch Delights, and to sample their Hiland Dairy white and chocolate milk. They also gave out bags with tattoos, crayons and coloring books donated by the Brooklyn Farm Bureau. Their daughterin-law, Katherine, is a board member on the Brooklyn Farm Bureau.

The Boelen family moved to Iowa from the Netherlands in 2009. In the Netherlands, they had 160 milking cows along with heifers with bloodlines in their herd from over 60 years old. Jan's dad, Jo, bought his first milking cow in 1947. They started with 235 cows when they moved here and today their family dairy farm operation has grown to milking between 1550 and 1600 cows. They have over 2,000 replacement heifers which vary in age. The youngest are at home with several at their heifer raiser in Durant, WI, and 10 miles north at the Poweshiek/Tama county line in a feed lot.

Katherine came up with the alternative idea for the drive-thru event since kindergarten classes and day care groups could not tour the farm due to the Covid-19 pandemic. Since it was such a success they plan to have it next year in June to celebrate Dairy Month.

Their free-will donation was a great success! They were able to donate \$1,300 to PIE (Partners in Education) at the BGM School to upgrade their playground. (picture to the right)
