## June TIPS from T.I.P.

#### **Installing a New Grain Bin?**

The State of Iowa requires specific clearances for electric lines around grain bins. T.I.P. Rural Electric Cooperative will provide assistance in planning for a safe environment for everyone working and living around grain bins.

The diagrams shown are according to the Iowa Electric Safety Code found in Iowa Administrative Code Chapter 199-25.2(3)b. An electric utility may refuse to provide electric service to any grain bin built near an existing electric line which does not provide the clearances required by the American National Standards Institute (ANSI) C2-2017, "National Electric Safety Code", Rule 234F. This paragraph "b" shall apply only to grain bins loaded by portable augers, conveyors or elevators and built after September 9, 1992, or to grain bins loaded by permanently installed augers, conveyors, or elevator systems installed after December 24, 1997. (As adopted by the Iowa Utilities Board).

T.I.P. and its power supplier, Central Iowa Power Cooperative, are required by the Iowa Utilities Board to provide this annual notice to farmers, farm lenders, grain bin merchants, and city and county zoning officials. If you have any questions concerning any clearance regulations, please call T.I.P. Rural Electric Cooperative at (800) 934-7976 before any new grain bin plans are finalized. For your safety, T.I.P. standards exceeds those specified in NESC. (See asterisk to the right.)

## **Pool Clearances**

When installing a pool, clearance in any direction from the water level, edge of a pool, base of diving platform, or anchored raft is required by (ANSI) C2-2012, "National Electric Safety Code", Rule T-234-3.

\*EXCEPTION: In reference to 236C of the Code, T.I.P. Rural Electric Cooperative will only recognize a "non-loading side" if the following criteria is met; both parties are in agreement to it; both parties sign a "grain bin agreement" form; and the bin in question is posted with "Non-Loading Side" signage.

# We're Ready for Storm Season. Are You?

Now that summer is in full swing, like many of you, we welcome more opportunities to be outdoors and enjoy the warmer weather. Summertime brings many of our favorite activities like cooking out with family and friends, afternoons on the water and simply slowing down a bit to enjoy life.

But summer months also make conditions right for dangerous storms. These potential weather events can cause destruction to our electrical system, but we want you to know that T.I.P. Rural Electric Cooperative crews are ready and standing by to respond should power outages occur in our area.

When major storms knock out power, our line crews take all necessary precautions before they get to work on any downed lines. We would encourage you to also practice safety and preparedness to protect your family during major storms and outages.

The Federal Emergency Management Agency (FEMA) recommends the items below as a starting point for storm and disaster preparedness, but you can visit <u>www.ready.gov</u> for additional resources.

- Stock your pantry with a three-day supply of nonperishable food, such as canned goods, energy bars, peanut butter, powdered milk, instant coffee, water and other essentials (i.e., diapers and toiletries).
- Confirm that you have adequate sanitation and hygiene supplies including towelettes, soap and hand sanitizer.
- Ensure your First Aid kit is stocked with pain relievers, bandages and other medical essentials, and make sure your prescriptions are current.
- Set aside basic household items you will need, including flashlights, batteries, a manual can opener and portable, battery operated radio or TV.
- Organize emergency supplies so they are easily accessible in one location.

In the event of a prolonged power outage, turn off major appliances, TVs, computers and other sensitive electronics. This will help avert damage from a power surge, and will also help prevent overloading the circuits during power restoration. That said, do leave one light on so you will know when power is restored. If you plan to use a small generator, make sure it's rated to handle the amount of power you will need, and always review the manufacturer's instructions to operate it safely.

Listen to local news or a weather radio for storm and emergency information, and check T.I.P. REC's Facebook, website or our app on your phone for power restoration updates.

After the storm, avoid downed power lines and walking through flooded areas where power lines could

be submerged. Allow ample room for utility crews to safely perform their jobs, including on your property.

Advance planning for severe storms or other emergencies can reduce stress and anxiety. At T.I.P. REC, we recommend that you act today because there is power in planning. From our co-op family to yours, we hope you have a safe and wonderful summer.

CIPCO has a Power Purchase Agreement (PPA) to purchase 100% of the power from the 100 MWAC Wapello Solar for 25 years. Clēnera partnered with RES to construct Wapello Solar in six months, creating approximately 250 jobs at peak construction.
